## Basic Core Elements of LTC Compliance Programs

The Affordable Care Act (ACA) makes compliance programs mandatory for all nursing facilities. An effective Compliance Program is a proven way to reduce exposure to penalties and liability issues and will be a condition of participating in Medicare and Medicaid soon. This informative webinar will review the required components of a compliance program, identify areas of compliance risk, and discuss the steps to take to achieve “operational” compliance programming.

Although Assisted Living facilities do not carry this same mandatory requirement, at least right now, it goes without saying though that ANY health care provider should be preparing to implement a compliance program. The ACA certainly does provide that all health care providers will be expected to eventually have such programs. So A.L.
